

Registry of Companies Fees

In dual currency display

Registration of a new company (including an oversea company and continuation of a foreign company in Malta)

The fees payable to the Registrar of Companies upon registration are calculated according to the company's authorised share capital as follows:

Authorised Share Capital	Fee Payable
Up to Lm2,000 (€4658.75)	Lm150 (€349.41)
Over Lm2,000 (€4,658.75) but not exceeding Lm5,000 (€11,646.87)	Lm150 (€349.41) plus Lm10 (€23.29) for each Lm1,000 (€2,329.37) or part thereof in excess of Lm2,000 (€4,658.75)
Over Lm5,000 (€11,646.87) but not exceeding Lm25,000 (€58,234.33)	Lm180 (€419.29) plus Lm5 (€11.65) for each Lm1,000 (€2,329.37) or part thereof in excess of Lm5,000 (€11,646.87)
Over Lm25,000 (€58,234.33) but not exceeding Lm100,000 (€232,937.34)	Lm280 (€652.22) plus Lm5 (€11.65) for every Lm5,000 (€11,646.87) or part thereof exceeding Lm25,000 (€58,234.33)
Over Lm100,000 (€232,937.34)	Lm355 (€826.93) plus Lm5 (€11.65) for every Lm5,000 (€11,646.87) or part thereof exceeding Lm100,000 (€232,937.34) provided that a maximum fee does not exceed Lm750 (€1,747.03)

Where there is an increase in the authorised share capital of a company, including following a conversion, amalgamation or division, the difference in registration fees between the fees paid on the authorised share capital prior to the increase and the fees payable on the authorised share capital following the increase, would be payable.

Registration of an annual Return of a company

In the case where the authorised share capital of the company:	
Does not exceed Lm5,000 (€11,646.87)	Lm70 (€163.06)
Exceeds Lm5,000 (€11,646.87) but does	Lm140 (€326.11)
